

- So far the process has been smooth and we have onboarded a lot of submitters.
- Our support team has resolved 682 tickets in the last three months since data file submission began.
- Overall it has been a collaborative experience with us working with submitters and we greatly appreciate the participation and feedback.
- Currently we are working on Stage II quality checks. We are being diligent about it and we want to make the best use of our time and yours.



- Thank you for your participation! We hope to continue to use surveys in the future to help us gather your feedback.
- Preference for Day of Week: Not Friday! (or particularly Thursdays).
 Tuesday was ranked 10% higher than Monday/Wednesday.
- Preference for Time (am/pm): 47% am, 52% pm. 12:30 pm CT for now. (1:30 pm ET, 12:30 pm CT, 11:30 am MT, 10:30 am PT)
- Meeting Frequency: Once a month or once every other month. The current plan is to keep at once a month (if we have agenda items) until after 2024 Registration closes in December, then we may go to every other month.



- Feedback: Better advance notice of meeting schedule. A recurring meeting works best.
 - Great suggestion, we will try and put a recurring meeting together for 2024 when we establish our cadence.
- Feedback: Always disclose or inform Payors when and if updates are made to the submission process, checks, etc.
 - We believe that this turbulence was related to go-live as we found some lastminute issues. Many submissions are passing the Stage I validation checks; our goal is to provide advance notice whenever possible.
- **Feedback:** Provide easier way to review and track data submissions.
 - We plan to provide this functionality in the submission portal.
- **Feedback:** Revisit requirement for 50 months' work of historical file submissions.
 - The regulation requires historical submissions from January 2019, forward. Also, from a research standpoint, claims data from pre-Covid years is crucial.
- Feedback: Can you send out the presentation via email to everyone instead of us having to go to the website.
 - Yes, we can send the link via email, but please keep in mind it will be posted online earlier than the email is sent out.



- Thank you for those who put their names in the hat.
- Currently working to define the scope of the Technical Working Group and time commitment to ensure people can participate without it becoming a burden.
- By next forum we will be able to announce how we expect it to work.



- Reminder: Registration needs to be renewed annually with the TX-APCD.
 - We will follow-up with a notification within the next 4 to 6 weeks that provides instructions on registration renewals.
- Renewals apply to exception and extension requests that were granted for the 2023 calendar year. These requests will expire on December 31, 2023.
 - After your organization's registration is updated for 2024, new exception and extension requests will need to be submitted for consideration for the 2024 calendar year.
 - Small Carriers with less than 10,000 covered lives are encouraged to submit extension requests early after registration renewal.

Note: This is a regulation requirement per TDI.
