


#### The components of E-Cigarettes (Ecigs)



#### Number of parts in a basic e-cig

- Battery
- Atomizer
- Cartridge







## The Rise of E-Cigarettes



#### The closed system:

<u>The cig-alike</u>: similar in size and shape to a traditional cigarette. Disposable, and cannot be used again (\$).

#### The open system:

- Reusable with disposable parts: Contain a rechargeable battery where the cartomizer is disposable - no need for e-liquids or refilling etc (\$\$).
- The "APV" (advanced personal vaporizer) or "mod" (modification): These e-cigs have a rechargeable battery and refillable cartomizers (\$\$\$).



# How to Choose the RIGHT E-Liquid Nicotine Strength For Your Device! 0-3 12-18 12-18 12-18

- E-Liquid strength is measured in milligrams (weight) per milliliter (volume); expressed as mg/mL
- E-Liquid, or E-Juice, comes in many strengths depending largely on the manufacturer, sometimes even as high as 42 or 56 mg/mL







"Below is a general guide that can help you work out the correct nicotine strength required.

Due to <u>Tobacco Products Directive</u> (known as TPD for short) that came into effect on **20th of May 2017**, the maximum strength of nicotine in an eliquid sold in the UK (and EU) is now limited to 20mg/ml (or 2.0%)."





## 2018 NAS Report





- There is substantial evidence that e-cigarette use increases <u>risk of ever using combustible</u> tobacco cigarettes among youth and young adults.
- Among youth and young adult e-cigarette users who ever use combustible tobacco cigarettes, there is moderate evidence that e-cigarette use increases the frequency, intensity, and duration of subsequent combustible tobacco cigarette smoking.
- There is insufficient evidence from randomized controlled trials about the effectiveness of e-cigarettes as cessation aids compared with no treatment or to Food and Drug Administration approved smoking cessation treatments

- Nicotine exposure during adolescence can cause addiction and can harm the developing brain.
- Hazardous compounds have been found in ENDS liquids, or in the heated aerosol produced by ENDS, including formaldehyde, acetaldehyde and acrolein, which are known cancer producing toxicants.
- Nicotine can cross the placenta and has known effects on fetal and postnatal development.
- Therefore, nicotine delivered by e-cigarettes during pregnancy can result in harmful consequences, including
  - Sudden infant death syndrome (SIDS)
  - Altered corpus callosum
  - Deficits in auditory processing
  - Obesity



#### **Nicotine influences:**


- Acetylcholine receptors, which have action on:
  - Cholinergic areas: which control
    - Muscle movement, Breathing, Heart rate, Memory, Motivation
  - Neurotransmitters and hormones, such as:
    - Acetylcholine, Norepinephrine, Dopamine, Serotonin, Vasopressin, Betaendorphin and Adrenocorticotropic hormone (ACTH).
      - Dopamine, produces feelings of pleasure/reward. It's the same neurotransmitter involved in addiction to cocaine and heroin.

**Strong Biologic Plausibility**: Reduced impulse control, deficits in attention and cognition, and mood disorders.





# What is Propylene Glycol (PG) and why is it used



- Propylene glycol is a clear, colorless liquid at room temperature. To exist in aerosol form, must be heated.
- In E-cigs, PG is added to dilute the pure liquefied form of nicotine and to serve as a vaporizable base.
- PG also allows atomization to take place at much lower temperatures than tobacco cigarettes.
- Propylene glycol is "generally recognized as safe" by FDA for ingestion, but little is known about the effects of inhaling it as a aerosol.





#### All of these have been found in e-cigarette/vape pen aerosol





Relative cancer potency modelled for common forms of nicotine delivery









# Federal, state and local policies related to e-cigarettes



- The Family Smoking Prevention and Tobacco Control Act (2009)
  - On April 25, 2014, FDA issued a proposed rule that would extend its regulatory capacity to additional tobacco products.
- At least 40 states have laws in place restricting e-cigarettes sales to minors (Gov. Abbott signed SB 97 in May 2015)
- Cities and counties are rapidly setting restrictions on the use of e-cigarettes
  - Implement laws to restrict use in venues including workplaces, restaurants and bars





## **E-Cigarette Constituents**



School of Public Health

- The Tobacco Control Act provides FDA authority to regulate cigarettes, cigarette tobacco, roll-your-own tobacco, smokeless tobacco, and any other tobacco products that the Agency by regulation deems to be subject to the law.
- The Food and Drug Administration (FDA) is proposing to deem products meeting the statutory definition of "tobacco product," except accessories of a proposed deemed tobacco product, to be subject to the Federal Food, Drug, and Cosmetic Act (the FD&C Act), as amended by the Family Smoking Prevention and Tobacco Control Act (Tobacco Control Act).

# SB 97: Signed in May 2015. Health and Safety Code Sections 161.081-8; 161.251-6; 161.301-2; 161.356; 161.452-457



- Prohibits <u>sale</u>, <u>purchase</u>, <u>or use</u> of e-cigarettes or nicotine containers to a minor under the age of 18.
   Upon conviction, a class C misdemeanor, including a fine up to \$500 may be imposed.
- Nicotine containers must be child-resistant.
- Retailers must post a sign.
- A retailer shall adequately supervise and train the retailers agents to prevent a violation.
- Conviction leads fine or awareness program.

# Section 38.006. E-Cigarettes and Tobacco Products on School Property



- The board of trustees of a school district shall:
  - Prohibit smoking or using e-cigarettes or tobacco as a school –related or school-sanctioned activity on or off school property.
  - Prohibit students from possessing e-cigarettes or tobacco products at a school-related or school sanctioned activity on or off school property.
  - Ensure that school personnel enforce the policies on school property.

# Westlake High School Student Handbook, 2017-18 *Tobacco and E-Cigarettes Prohibited*

- Students are prohibited from possessing or using any type of tobacco product, electronic cigarettes (e-cigarettes), or any other electronic vaporizing device, while on school property at any time or while attending an off-campus school-related activity.
- The district and its staff strictly enforce prohibitions against the use of all tobacco products, e- cigarettes, or any other electronic vaporizing device, by students and all others on school property and at school-sponsored and school-related activities. [See the Student Code of Conduct and policies at FNCD and GKA.]





# Section 28.004. E-Cigarettes and Tobacco Products on School Property



- A school district must publish in the student handbook and district website a statement:
  - Of polices adopted to ensure adequate PA.
  - The number of times the SHAC has met in the preceding year.
  - Whether the district complies vending machine and food service regulations.
  - Whether the district has adopted and enforces policies and procedures for use of e-cigarettes and tobacco.





#### **Comptroller Rules**



If the Comptroller finds, after notice and hearing, that a retailer has sold cigarettes, cigars and/or tobacco products to a minor, at a place of business for which a permit is issued, the Comptroller may suspend or revoke the permit for that place of business or assess an administrative fine in an amount up to \$1000 per violation. (Tax Code, Sec. 154.1142 and Sec. 155.0592)
