



# Staffing the Eligibility System



HHSC has had major backlogs on Medicaid and SNAP applications/renewals in 2022



Aug. 2022

HHSC increased base salaries for clerks, eligibility advisors and supervisors. Frontline eligibility advisors received 25% salary increase.



2023

Budget: supplemental 2023 and 24-25 bills fund the 2022 increases.

Early in 2022, HHSC identified shortage of about 1,000 eligibility staff




In mid-December, HHSC reported a 6% vacancy rate-a shortage of about 300 workers-- for Texas Works Advisors, improved from 21% earlier in 2022.


## Modernize the SNAP Vehicle Asset Test Bill #: HB 1287/ SB 273

### **Problem:**


- The SNAP Vehicle Asset Test prevents thousands of hungry families from accessing food assistance for several reasons:
- It is outdated.
- It disproportionately harms Black and Latino households, especially two-parent and multigenerational households.
- It jeopardizes people's ability to work.
- It harms families when inflation is high.

#### **Solution:**

Texas must modernize the SNAP Vehicle Asset Test by applying an inflationary adjustment to the current limits.

# REDUCE PAPERWORK FOR SNAP FAMILIES WITH CHILDREN Bill #:HB 2836



### **PROBLEM:**

- •Unnecessary paperwork requirements cause eligible families to lose their SNAP benefits and risk hunger until they can reapply for assistance.
- •Texas only certifies families with children for a maximum of 6 months of benefits despite federal law allowing for 12 months with a report of any changes at 6 months.
- •The recertification process, including an interview, is often difficult for families to complete within the 10-day window and failing to recertify in time is common.
- •The extra paperwork burden leads to even longer delays in cases being approved by HHSC.

### **SOLUTION:**

Texas should allow for 12 months of continuous eligibility, with an interim report at 6 months, for SNAP families with children.

## Reduce Hunger at Community Colleges Bill #: HB 1501 SB 557



### **Problem:**

- •College tuition costs are rising, and with current inflation, so are the costs of housing, food, and other necessities. The inability to afford these basic needs is the number one reason cited by community college students for not completing their education.
- •Unfortunately, federal regulations severely limit access to SNAP for college students, especially those attending school more than half-time.

### **Solution:**

•Texas HHSC should identify college degree programs that are vocational or technical in nature, so that students enrolled in these programs can receive SNAP.

# Surplus Agricultural Products Grant: Article VI, Dept. of Ag. Rider 10(a)



### **Problem:**

- Texans everywhere are struggling with the rising cost of food, and food banks are still seeing one-third more clients than they did prior to the pandemic.
- While inflation is hurting both Texas farmers and lowincome Texas families, food banks are also coping with the rising costs of food and fuel.
- While need is increasing, USDA support for food banks and local donations fell sharply this year. Food banks project they will receive 31% less food in 2022 compared to 2021.

### **Solution:**

• The Texas Legislature should ensure that food banks can continue to provide healthy produce to struggling Texans across the state by increasing funding for the Surplus Agricultural Products grant to \$20M for the biennium.

## Healthy Food Is Good Medicine Bill #: HB 2983



### **Problem:**

- Hunger and health are intricately linked. A poor-quality diet that lacks nutritious food has detrimental effects on a person's physical and mental health.
- Food insecurity is associated with higher health care costs.
   The Center for Disease Control suggests that food insecurity adds about \$2B annually to health care cost in Texas.

### **Solution:**

 Medically-based nutrition programs, such as Medically Tailored Meals, should be funded by Medicaid and reimbursement provided to community-based organizations who deliver the meals.

## Evidence base for Food is Medicine

Improved Food Insecurity

Improved dietary quality

Decreased inpatient admissions and ED visits

Decreased medical spending/healthcare costs

Target population specific outcomes: decreased HgbA1c, decreased preterm births

# **Express Lane Eligibility**

HB1599-Bucy

Leverage already-verified information from one state program (such as SNAP) to facilitate enrollment of eligible children in health coverage.

400,000 uninsured Texas children are eligible for Medicaid or CHIP
